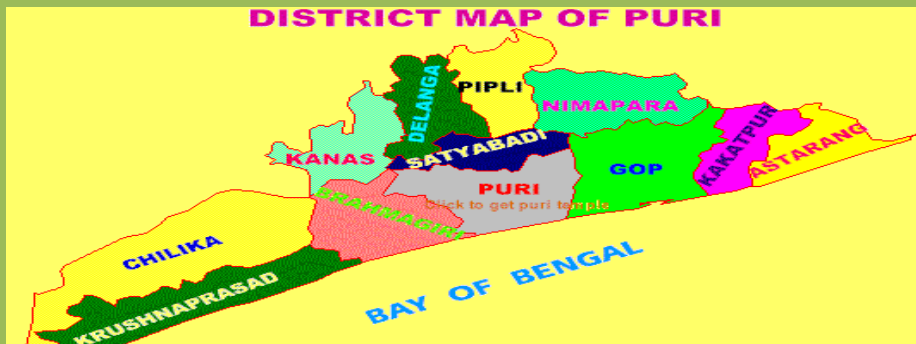

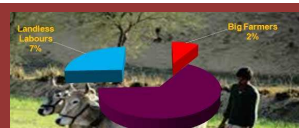

## LOOKING FORWARD

The displacement or migration affects the children first, their education and health jeopardized. Certainly it affects the livelihood of the household also.
- ✓ **FREEDOM** intends to create certain positive impact on community, particularly the poor and the marginalized through its activities & programs. The impact or changes are both tangible & non-tangible, but the nontangible part is the main element in the developmental process. The process of institution building will certainly create "**Body of Opinion Makers**" and Natural Leaders in the community. Local community is mobilized and organized so that it take a proper shape and in due course take active participation with leadership in the development of the region.
- ✓ These initiatives shall have "ripple effect" in the region. The ripple effect in the surrounding area requires right direction & streamlining for this **FREEDOM** will have to facilitate the expanded community initiatives.
